5. Do not write anywhere else in the form (फॉर्म में कहीं और न लिखें)

Remember these points while taking the photo (फोटो लेते समय इन निर्देशों को याद रखें)

1. Ensure the photo is taken of the entire mandate form including the black borders (सुनिश्चित करें कि तस्वीर काली सीमाओं सहित पूरे फॉर्म की है) DO NOT TAKE PHOTO OF THIS GREY AREA.
2. Ensure the photo is clear and the texts are visible (सुनिश्चित करें कि फोटो स्पष्ट है और लिखा दिखाई दे रहा है)
3. Ensure the form is not folded or has any shadows (सुनिश्चित करें कि फॉर्म मुड़ा हुआ नहीं है या उसकी कोई छाया नहीं है)

Note: Mandate may get rejected if the above instructions are not followed. (नोट: यदि उपरोक्त निर्देशों का पालन नहीं किया जाता है तो जनादेश खारिज हो सकता है।)
